TO HAVE VITAL RECORDS MAILED, A SELF-ADDRESSED, STAMPED ENVELOPE IS REQUIRED.

No Charge

55 ILCS 5/3-5015 – Certificates of Discharge...states that military records are only accessible to the person named in the document, dependents who qualify for veteran death benefits, or Veteran's Administration to protect the veteran from identity theft. All veteran records are isolated and protected from any public view or access. NOTE: Spouse, brother, sister, cousin, friends <u>CANNOT</u> obtain a copy of a persons DD214 UNLESS they have written authorization from the named person. If a person is deceased, a compete service record is available to the parents, spouse, children, or next-of-kin. Next of kin are the <u>un</u>married widow or widower, son/daughter, father/mother, brother/sister of the deceased veteran. An ex-wife/husband is not entitled to a copy. Authorized third party requesters (lawyers, doctors, etc. may submit requests for information from individual records with the veteran's or next-of-kin's signed and dated authorization. The authorization should specify exactly what is to be allowed to be released to the third party. Authorizations are valid 1-year from date of signature.
